Applying For Your Resident Surplus Line Broker License Through NIPR

NOTE: Please allow 3-5 business days following the passing of your exam to apply for a new line of authority through NIPR.

- 2. Click **LICENSING CENTER** at the top of the page.
- 3. Select Add a Line of Authority on the dropdown menu.
